In the past you have supported our Kentucky Derby and/or our Santa's Sip & Sail.

Unfortunately, because of COVID, both events had to be cancelled. These events are critical to our operation, but factor in COVID, and our need for financial support, it is devastating. Since March 2020, we have experienced over a 300% increase in services, over 800 new households have come to us for assistance and we have distributed over half a million meals. As we look forward, we must plan for an increase in requests for help this holiday season. We are anticipating providing gift packages to 2,500 children this year.
